One self-study training module is published each month, except in December, including a short training quiz to document staff participation. Training notes are also provided for the person responsible for administering the training, including a key to the quiz. Training materials are provided in PDF format for easy printing or electronic distribution to your staff. As an alternative, training modules may be discussed in a staff meeting and a training log signed to serve as documentation that required training was provided.

E-COMPLIANCE TRAINING (ECT)

ECT was developed for larger organizations to provide paperless training documentation and an alternative to manual administration. The training curriculum is the same as listed above under ANNUAL STAFF TRAINING and SPECIAL TRAINING MODULES, however, the training modules are made available through a user-friendly, online platform that may be used by staff members to view training materials and take a short training test. Continuing Education (CE) credit is offered for each completed training module. Management personnel will be provided special access to track workforce member participation. Please see the fee schedule on page 4 for pricing.

- **How It Works** Each employee is provided with online access to monthly training materials and short training tests that serve as documentation of the training provided. Employees may print a transcript upon completion of each training module. Training reports can be pulled at any time by a management contact at your practice to monitor participation.
- **New Hire Orientations** ECT includes initial OSHA, HIPAA and OIG training modules for new hires or for first-time training of your existing staff.
